Rob Langezaal to resign from de Volksbank

Jan van Rutte, Chairman of the Supervisory Board: "We are grateful to Rob Langezaal for his commitment and contribution to developing de Volksbank's Manifesto. This Manifesto, which is now being used as a guideline for our employees' actions, puts the customer at the centre of our business and connects all the brands of the bank through a collective social profile".

Maurice Oostendorp, Chairman of the Board of Directors: "Under Rob Langezaal's management, the number of customers at de Volksbank's brands (ASN Bank, BLG Wonen, RegioBank and SNS) grew strongly and customer satisfaction also improved. During this period, customer relationships were expanded and modernised: digitally, mobile as well as interpersonally, i.a. through franchise organisations, which was new to the banking sector".

The Supervisory Board will start a procedure for his succession.
