On 14 April 2008, the Company purchased into treasury 29,000 EUR shares at a price of EUR 9.44 (the "Transaction")

The Board of the Company has resolved with immediate effect to cancel 29,000 of its EUR issued shares, thereby reducing the number of outstanding number of issued EUR shares of the Company to 75,599,535.(the "Transaction")

Following the Transaction, there are now in issue (to the exclusion of those held in treasury) 68,421,695 Euro Shares, 24,614,802 US\$ Shares and 30,990,033 Sterling Shares. The total number of shares held in treasury are 7,177,840 Euro Shares, 2,194,401 US\$ Shares and 3,038,325 Sterling Shares.
