Boskalis update on purchase of Dockwise shares

Royal Boskalis Westminster N.V. ("Boskalis") announces that it has acquired 3,390 ordinary shares in Dockwise (the **Shares**) in the course of trading today. All these Shares were acquired through Euronext Amsterdam and were purchased at an average price of EUR 18.50 per Share with a maximum price of EUR 18.50 per Share (which equals NOK 137 as per today).

Boskalis now holds at total of 15,935,144 Shares, representing approximately 40% of the Shares. Together with the irrevocable commitments obtained by Boskalis, more than 90% of the Shares is already acquired by, or committed to, Boskalis.
